
Ministry of Earth Sciences invites e-tender for maintenance of "HORTICULTURE AND GARDENING" for MoES building, Prithvi Bhavan, at IMD Complex, Lodhi Road, New Delhi from reputed contractors/firms/companies etc. in two bid system (Technical and financial). The approximate area for providing the services is 26,900Sq.Ft. This is an e-tender and Technical & Financial bids are to be submitted on-line only.

2. Tender should be accompanied by Earnest Money Deposit in the form of a Bank draft or FDR or Bankers Cheque or Bank Guarantee of Rs.30,000/- (Rupee thirty thousand only) from any Indian Commercial Banks drawn in favour of DDO, Ministry of Earth Sciences, New Delhi-110003.

a) EMD of Rs.30,000/- (Rupee thirty thousand only) should be dropped in the box kept in the General Section on or before the last date, i.e. 3:00PM on **18.12.2019**. Firms claiming exemption from submission of EMD should submit documents like MSME certificate in support of their claim.

b) In place of bid Security (EMD) the firms can submit a declaration that if they withdraw or modify their Bids during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids documents, they will be suspended for the period of 02 (Two) year from being eligible to submit bids for contract with MoES.

c) Last date of receipt of tender is **18.12.2019** by 3.00 pm sharp. Technical bid will be opened on dated **19.12.2019** at 3.30 pm, in the presence of representative of the firms, if any. Date of opening of Financial Bid will be intimated later only to those bidders who qualify the Technical bid evaluation criteria. Ministry reserves the right to reject any or all the tender received without assigning any reason.



d) The Contract shall be for a period of One Year from the date of award and extendable for further one Year subject to continuous satisfactory performance.

### **Instruction for Online Bid Submission**

The bidders are required to submit soft copies of their bid electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.


More information useful for submitting online bids on the CPP Portal may be obtained at: <https://eprocure.gov.in/eprocure/app> .

#### **REGISTRATION**

- Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (<https://eprocure.gov.in/eprocure/app>) by clicking on the link “online Bidder Enrollment” on the CPP Portal which is free of charge.
- As part of the enrollment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrollment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificated with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify/TCS/nCode/eMudhra etc.), with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC’s to other which may lead to misuse.
- Bidder than logs on to the site through the secured long-in by entering their user ID/password and the password of the DSC/ e-Token.

#### **SEARCHING FOR TENDER DOCUMENTS**

- There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders many combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the requirement documents/tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender



document.


- The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

#### **PREPARATION OF BIDS**

- Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- Please go through the tender advertisement and the tender document carefully to understand the document required to be submitted as part of the bid. Please note the number of covers in which the bid document have to be submitted, the number of documents- including the names and content of each of the document that need to be submitted. Any deviation from these may lead to rejection of the bid.
- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender documents/schedule and generally, they can be in PDX/XLS/RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which help in reducing size of the scanned document.
- To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as part of every bid, provision of uploading such standard document (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### **SUBMISSION OF BIDS**

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- The bidder has to digitally sign and upload the required bid document one by one as indicated in the tender document.
- Bidder has to select the payment option as "offline" to pay the tender fee/EMD as applicable and enter details of the instrument.
- Bidder should prepare the EMD as per the instructions specified in the tender documents. The original should be dropped in the Drop Box kept in General Section of MoES, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- Bidder are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has given as a standard BoQ format with the tender documents, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white colored (unprotected) cells with their respective financial quotes and other details completed, the bidder should save it and submit it only online,



without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

- The server time (which is displayed on the bidder's dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized person until the time of bid opening. The confidentiality of the bids is maintained using the secure Socket Layer 128-bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.


#### **ASSISTANCE TO BIDDERS**

#### **CHAPTER-I**

##### **1. Instruction to Bidders**

Ministry of Earth Sciences invites tender for maintenance of "HORTICULTURE AND GARDNING" for MoES, (Prithvi Bhavan), at IMD Complex, Lodi Road, New Delhi from eligible contractors/firms/companies etc. The detail of terms and conditions, schedule of work/ Specifications and format for technical and financial bid are available in the tender document. The approximate area for providing the services is 26,900Sq. feet. The bidders are instructed to go through Tender form (line by line) thoroughly before quoting their rates.



- 1.1 The tender is liable to be ignored if complete information is not given therein.
- 1.2 All bidders and/or their representatives, if they should desire, may be present at the opening of the tender by the constituted Committee at the time and date as specified in the schedule. It may be noted that in no circumstances delay in submission after specified time will be entertained.
- 1.3 Tenders are requested to submit their quotations /rates/individual job basis, for per month basis (kindly referred to Annexure-II).
- 1.4 Price quoted should be in Indian Currency and should be inclusive of all charges. In no case any enhancement in the approved rate will be entertained by MoES during the currency period of AMC. Tenders not complete in this respect are liable to be ignored. The quotations shall be furnished in on-line only i.e. technical bids along with EMD etc Annexure-I and Financial bid Annexure-II.
- 1.5 The bidders shall, wherever, call upon to do so, give full information with reference to the services in hand and shall also permit the nominated officer of MoES to inspect the premises of the bidders at all reasonable times and shall give full assistance and information as may be required by him in connection with the contract.
- 1.6 The agency, while submitting their tender form, shall enclose self-attested Photostat copies of experience, trade licence essential for carrying out the activities under reference, license under contract labour act, and any other documents in support of permission from the Competent Authority for carrying out the activities under reference. Tender form incomplete in any respect and not supported with Earnest Money and such requisite documents, will be rejected by MoES.

## CHAPTER-II

### 2. Condition of Contract

**21** The contract, if awarded, will be initially for one year from the date of award and extendable for further one year subject to continuous satisfactory performance. However, on failure on this aspect by the contractor, the MoES will have the right to terminate the contract forthwith. In such case of unsatisfactory performance on the part of Contractor in addition to forfeit of the performance guarantee deposited by the contractor, action can be initiated by this Ministry to blacklist the contractor's firm/agency for a period of one year.

**22** The contractor shall not sublet, transfer or assign the contract or any part thereof. In the event of the contractor contravening this condition, in addition to forfeiture of Performance security, the firm can be blacklisted by this Ministry.

**23** The bidder shall have to deposit earnest money of an amount of Rs. 30,000/- with their tender failing which the tender is liable to be rejected out rightly. The earnest money is to be paid by **Demand draft**, the same should be drawn in favour of DDO,

Ministry of Earth Sciences, payable at New Delhi and attached with the technical bid. Cheques/Cash will not be accepted towards Earnest Money. In the event of the withdrawal/revocation of tenders before the date specified for acceptance, the earnest money shall stand forfeited. The EMD of the successful bidder will be refunded on receipt of performance security.

**24** On acceptance of the tender, the successful bidder shall within the period specified by the Ministry, deposit a performance security, a sum equivalent to 10% of the tender value of the contract for one year valid beyond 60 days of all contractual obligations. The performance security may be furnished in the form of DD, fixed deposit receipt from a commercial bank, bank guarantee from a commercial bank payable at New Delhi in favor of DDO, Ministry of Earth Science New Delhi-110003.


**25** If the successful bidder is called upon by MoES to deposit performance security and the Bidder fails to provide the performance security deposit within the period specified (within 15 days). Such failure will constitute a breach of the contract and MoES shall be entitled to forfeit the earnest money and this Ministry can also initiate action to blacklist the concerned firm for a period of one year for participating in the Tenders of this Ministry.

**26** On completion of the contract in all respects, the Performance Security Deposit will be returned to the contractor after 60 days from the completion of all contractual obligations (without any interest) subject to satisfactory performance and after all the items, which may have been issued to the contractor and other property belonging to MoES, are received back in the same condition as were received by the contractor. Any loss/damage to the item/property of MoES shall be recovered from the contractor.

**27** MoES, may at any time, by notice in writing, summarily terminate the contract without compensation to the contractor in any form in case it is felt by this Ministry that the bidder's work has not been satisfactory or in any other event where the firm is facing some legal problems which may affect their performance working in this Ministry. The decision of this Ministry shall be final in this regard.

**28** i). The contractor shall fully comply with all the applicable laws/rules and regulations relating to Contract Labour (Regulation and Obligation) Act 1970 and Contract Labour (R&A) Central Rule 1971, Provident Fund Act including the payment of PF Contribution, Payment of Bonus Act, Minimum Wages Act, Workmen Compensation Act, ESI Act, Essential Commodities Act, Migrant Labour Act and/ or such other act passed by the Central, State, Municipal or Local Govt. agency including TDS as per income Tax Act applicable from time to time. Same as 5.4.

ii) The contractor shall be responsible for proper maintenance of all registers and records. He shall make regular and full payment of labour charges/salaries and other payments as per labour laws under Minimum Wages Act and payment of wages to his workman deputed for the work and furnish necessary documents as and when asked for.



iii) The vendor should ensure to get police verification done before actual deployment and copy of Aadhaar card etc. should be furnished of persons deployed within 2 weeks of award of work for maintaining biometric attendance.

**29** In the event of any dispute or difference relating to the interpretation and application of the provisions of the contracts, such dispute or difference shall be referred by either party to the Arbitration of one of the Arbitrators in the Ministry of Earth Sciences to be nominated by the Secretary to the Government of India. The award of the Arbitrator shall be binding upon the parties to the dispute. Provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary/Additional Secretary when so authorized by the Law Secretary, whose decision shall bind the Parties finally and conclusively. The parties to the dispute will share equally the cost of arbitration as intimated by the Arbitrator.”

**210** . The Competent Authority reserve the right to reject any or all tender without assigning any reason whatsoever.

**211** After evaluation of the technical bids, the financial bids of only the technically qualified bidders shall be opened for arriving at L-1 bidder.

**212** In case of failure by contractor /firm to comply with the provision of the terms and conditions mentioned in this tender document or the agreement to be signed between MoES and the successful bidder, the competent authority of this Ministry reserves the right to terminate the contract and to forfeit the performance security & to blacklist the firm.

**213** The contractor shall not be entitled to assistance either, in the procurement of raw materials required for the fulfillment of the contract or in the securing of transport facilities.

**214** The agency shall be responsible for beautification and proper maintenance of horticultural garden, within the Ministry of Earth Sciences, building I.M.D. complex, Lodi Road, New Delhi- 110003 including new plantations of trees and saplings, time to time.

**215** The contractor/ agency will be responsible for compliance of all laws, acts and rules made under there, statutory orders issued from time to time in relation to the environment and man-power deployed by them for performance of the job under reference and the MoES will have a right to be indemnified in respect of any consequences resulting from any breach or violation by the contractor of such rules, statutory obligations etc.

**216** Except supply of free water by the MoES in the garden, all other inputs like sapling, seeds, organic manure/fertilizer and all tools & equipment used for growing flowers & plantation, their watering or for cutting grass & removing weeds, are to be supplied by the vendor and disposing off the wastes are to be borne by the vendor.



2.17 The contractor will be responsible for such conduct of the persons engaged by him in MoES, which will be conducive for maintaining as harmonious atmosphere as expected in MoES and will be responsible for any act & omission of such persons.

2.18 In the event of any violation of laws, rules, statutory provision by the contractor, this will amount to breach of contract and in such case, the Ministry will have the right for terminating the contract, forthwith, without giving any notice or assigning any reason.

2.19 Service provider will be required to maintain the entire area covered in the contract in best conditions throughout the year, irrespective of the weather condition. Failure on the part of the contract to maintain the area in the desired condition shall invite a penalty of 1% per week of the period during which the area remained out of the desired condition, subject to a maximum of 10%.

2.20 For effective and efficient operation of the horticulture/gardening services in the campus the agency will provide dedicated Manpower (04 Malies ) who will remain in the institute during working hours.

2.21 The court case, if any, is subject to jurisdiction of Delhi/New Delhi.

### Chapter-III

#### 3. Eligibility Criteria:

3.1 The bidder should have a permanent place of business in NCT of Delhi/NCR or their regional Office in NCT of Delhi /NCR and the complete Postal Address, Telephone/Mobile/Fax/E-mail address, etc. should be provided, while submitting the completed tender form.


3.2 The Bidder should have an Average Annual Turnover of Rs. 3 lakhs during the last 3 financial year. ( A certificate from C.A or Annual Audited Statement of Accounts may be enclosed)

3.3 The firm should have relevant license like labour license etc for the purpose of taking up Horticulture/gardening work in Delhi (Copies to be enclosed)

3.4 Earnest money Deposit as specified under para 2 above.

3.5 The firm should possess PAN/TIN/ST/GST Nos. (copies of relevant documents to be enclosed)

3.6 Experience in having successfully completed similar works during the last 3 year ending last day of month previous to the one in which application are invited as per the following:-



(a). Three similar completed works costing not less than Rs 4,00,000/-/- in each work;

OR

(b) Two similar completed works costing not less than Rs. 5,00,000/- in each work;

OR

(c). One similar completed work costing not less than Rs. 8,00,000/-

**Note:-** Similar works mean such horticulture/gardening work in a Central Govt./State Govt Deptt./Office or in Central PSU.

**Note:-** Scanned documents in support of each of the above eligibility conditions should be enclosed with the technical Bid. Simple information without supporting documents shall not be considered as valid.

**Selection Criteria:**

The firm which quotes the lowest overall rate (including taxes etc.) shall be awarded the contract. In case 2 firms quotes the same rate, the firm which has got more experience in the relevant field shall be awarded the contract. The decision of the of the competent authority of this Ministry shall be final in this regard. It is also stated that the bids which quotes the amount of service charges of the firm as Nil shall be treated as unresponsive and will not be considered.

**CHAPTER-IV**

**4. Specification and allied technical details**

**4.1 Scope of Work:**

(i) The day to day maintenance of lawn (26,900 Sq.feet.) includes laying of new grass in open space of the garden wherever required any time, weeding, trimming and pruning of grass by mowing with grass cutting machines, top dressing, using of manure, organic manure/fertilizer, spraying of insecticides, pesticides, fungicides, sweeping and watering etc and patch work by planting the dob grass where dead.

(ii) The maintenance of trees, shrubs and creepers include the maintenance of all trees, flowers & flowering as well as decorative plants, shrubs and creepers by their manuring. Watering hoeing, pruning and trimming, replacement of old dead plants by new and to ensure enough supply of air and water. Circular kiaries around the tree are to be prepared. The creepers across wall are to be provided support by rope and other

trees and shrubs by bamboo sticks as required.

(iii) The beautification work includes new plantation of trees & sampling time to time.

(iv) The maintenance of hedges includes their watering, hoeing of channels, pruning and trimming and replacing old and dead plants by planting the new saplings/cutting deal/uprooted plants etc.

(v) The entire area of the garden is to be kept covered with seasonal flowers/ small and decorative plants throughout the year, with proper arrangement of gullies & channels.

(vi) The curb stones along with roads and decorable pots in the campus shall be washed at least once a month.

(vii) The potted plants are to be maintained at least at the present level of maintenance in the building, both inside the corridors on all floors and around the building.

(viii) For having on estimate of the work involved, the interested parties should visit the building on any working day to know the amount of work involved, before submitting their bids.

(xi) The contractor should provide organic manure/ fertilizer.

## CHAPTER-V

### 5. Price Schedule

5.1 The Bidder(s) shall quote price in clear terms. Break up should abide by the Format for Financial Bid described in Financial Bid format in Annexure-II The taxes applicable should be shown separately and clearly. No further taxes existing as on date will be applicable. Any change in taxes or levies structure by the Government of India will be applicable at the time of billing. The Financial Bids should strictly conform to the format to enable evaluation of bids. Bids having any hidden costs or conditional costs will be liable for straight rejection.

5.2 Prices quoted by the Bidder shall be fixed and no variation will be allowed under any circumstances.

5.3 Prices shall be quoted in Indian National Rupee.

5.4 **Payment:** The contractor will be required to submit bill on monthly basis along with ESI, EPF challans & Bank Transfer statement etc. on the basis of Biometric Attendance of contractual staff. The payment will be reimbursed by MoES as per the terms and conditions after deducting TDS/GST or any other tax at prevailing rates.

5.5 The rates once accepted by MoES shall remain unaltered throughout the period of contract, including any extended period.

5.6 The tender will quote the rates in respect of job/services describe above in various paras and will fill Annexure-II appended herewith.


