#### I. COMPANY PROFILE

North Eastern Regional Agricultural Marketing Cooperation Limited (NERAMAC) was incorporated on 31.03.1982 with the objective to promote the Agri-Horti produces and products in the North Eastern Region to the maximum possible extent through a network of certres and to make necessary arrangement for its processing and marketing. NERAMAC is a Schedule 'C' CPSE in trading and marketig sector with the administrative jurisdiction of Ministry of Development of North Eastern Region.

Its Registered and corporate office in Guwahati, Assam.

The company employed 22 regular employees (Executives: Nil and Non-excecutives: 22) as on 31.03.2021.

The authorized and paid up capital of the company are Rs. 10 crore and 7.62 crore respectively as on 31.03.2021.

The Shareholding of the Government of India in the company is 100% through Ministry of Development of North Eastern Region (MDoNER) and North Eastern Council (NEC).

#### II. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director is the Chief Executive of the Corporation and accountable to its Board of Director and Government of India. He/She is responsible for the efficient functioning of the Corporation for achieving its corporate objective and performance parameters.
