Borehole Geophysics Research Laboratory (BGRL), Karad, Maharashtra, has been established by the Ministry of Earth Sciences (MoES), Government of India, to address the genesis of earthquake occurrence in Koyna region by a multidisciplinary approach, including geological, geophysical, and seismological observations, numerical modelling and deep Drilling in the near-source region. To strengthen its activities, BGRL is inviting applications from retired Govt. employees for the following Consultant positions on a contract basis during 2025-2026 under the project "Scientific Deep Drilling in the Koyna Intraplate Seismic Zone, Maharashtra" at Borehole Geophysics Research Laboratory (BGRL), Karad. The engagement is purely temporary and on a contractual basis. Selected candidates would be engaged initially for a period of six months, extendable up to the approved duration of the program subject to requirements of the institute. - 8. Intending retired officers, having good health and willing to work as consultants / visiting fellow at MoES-BGRL, Karad may apply for the post, along with copies of PPO, LPC and APARS for the last three years.

Terms and Conditions

Eligibility:

- 1. The applicant should not have attained the age of 63 years on the date of the Interview and should be in good health for discharging his/her official duties effectively.
- 2. The applicant should have a fair knowledge of computer applications such as MS Word, MS Excel and Power Point etc.
- 3. The applicant should have good communication and interpersonal skills and should be well-versed in noting/drafting.
- 4. The applicant should have expertise in-office procedures, etc.

Engagement:

2. Extension of tenure will be considered based up to the duration of the project, and will be based on performance review. No extension will be granted beyond the age of 65 years or as per the applicable government guidelines issued from time to time.

Working Hours and Leave:

- 1. The Consultant shall be required to observe the normal office timing and may also be called upon to attend the office on Saturday, Sunday or any holiday in case of emergency or work.
- 2. Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a Calendar year may not be allowed.

1. The Consultant shall be paid a fixed monthly amount calculated as under:

- 2. The amount of remuneration so fixed shall remain unchanged for the term of the contract. Release of monthly remuneration is subject to production / submission of satisfactory performance certificate from the concerned controlling officer.
- 3. The Income Tax or any other tax will be deducted at source as per Government instructions.

Confidentiality of data and documents:

- 1. The Intellectual Property Right (IPR) of the data collected, as well as deliverables produced for the Ministry/organization shall remain with the Ministry.
- No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of his assignment or during the course of assignment for the Ministry without the express written consent of the Ministry.
- 3. The Consultant would be required to sign a non-disclosure undertaking as per Annexure-1.

Conflict of Interest:

1. The Consultant shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Ministry nor will he indulge in any activity outside the terms of the contractual assignment.

Termination of Agreement:

The Ministry may terminate the contract to which these terms apply, if:-

1. The Consultant is unable to address the assigned work.

- 2. Quality of the assigned work not to the satisfaction of the Controlling Officer/ Competent Authority in the Ministry.
- 3. The Consultant is found lacking in honesty and integrity.
- 4. The Competent Authority in the Ministry may also terminate the contract at any time without giving any notice and also without assigning any reason.
