Sub: Assigning additional charge of the post of Director, National Institute of Ocean Technology (NIOT), Chennai.

The undersigned is directed to refer to the Ministry of Earth Sciences' D.O. No.MoES/27/04/2014-Estt. dated 20.04.2015 and OM No.MoES/18/13/2013-Estt. dated 22.05.2015 on the above mentioned subject.

- 2. While considering the above, the ACC has directed the Ministry of Earth Sciences to:
- (i) review the promotion granted to Dr. Atmanand as Scientist 'G' under FCS as per applicable instructions and submit the case for consideration of ACC at the earliest:
- (ii) relieve Dr. Atmanand from the additional charge of the post of Director, NIOT with immediate effect:
- (iii) consider assigning the additional charge of the post to a suitable person with the approval of the competent authority; and take necessary action to make regular appointment to the post, at the earliest;
- (iv) ensure taking prior approval of the ACC before assigning the additional charge of the post in such cases as per DoPT's prescribed instructions on the subject; and
- (v) fix responsibility of the officers concerned for promoting Dr. Atmanand as Scientist 'G' w.e.f. 21.10.2009 without following the due process and without the approval of the Competent Authority.
- 3. Regarding the proposal for entrustment of additional charge of the post of Director, NIOT to Dr. Atmanand from 22.10.2014 till 05.07.2015, the ACC has directed the Ministry to first explain the reasons for entrusting additional charge of the post to Dr. Atmanand.
