over grade. The Committee will also keep in mind, apart from the accomplishments of the officer during the period under review, keenness exhibited in the pursuit of his/her profession, ability to take up higher responsibilities including R&D capabilities, managerial/leadership qualities (as applicable) etc.

5.2 The Selection Committee, while considering each case, may recommend, based on its assessment, any one of the following:

(a) Promotion of the Officer to the next higher grade from the rationalised date on which the case is considered.

OR

(b) Promotion of the Officer to the next higher grade from the next rationalised date after the date on which the case is considered (i.e. delay by six months).

OR

(c) Status quo - i.e. no change in the grade.

5.3 Retraction

In respect of those who have been recommended status quo, their cases will again be considered by the Screening Committee after a period of one year only, subject to satisfactory performance during the period. However, if the candidate fails to get promoted in two consecutive interviews, his/her subsequent reviews will be after a gap of two years only on every occasion, except in the case of promotion from SSO-II to SSO-I, where the screening will be done every year.

5.4 Approval of the recommendation of the Selection Committee

The recommendations of the Selection Committee is further considered by the appropriate authority as prescribed in Annexure - I, who takes decision on each case. The decision of such authority is final.

7.0 Filling up of vacancies in the post of Scientist

7.1 A scientist promoted after a review carries the post with him and consequently no vacancy is caused at the lower level. Where a vacancy is caused due to a scientist vacating a post by superannuation, resignation, etc. the post that falls vacant will be filled in at the original level sanctioned.

OFFICE MEMORANDUM

Subject: Career opportunities for scientists in PST - Procedure for selection/review under the merit promotion scheme (flexible complementing scheme).

1.0 The following is the review procedure in respect of scientists in the grade of Senior Scientific Officer - II and above for promotion under the flexible complementing scheme:

2.0 Aspects of promotion

2.1 A scientist is eligible for promotion upto and including the level of Adviser (Rs.5900-7300) through the process of periodical reviews.

3.0 The minimum eligibility period for being considered for promotion under the scheme is as follows:

4.0 Procedure for review

4.1 There are two distinct phases of Review under flexible complementing scheme:

(a) Screening by the duly appointed Screening Committee

(b) Interview by the duly appointed Selection Committee of those who qualify in the screening procedure.

The composition and mode of constitution of the Screening/Selection Committee and competent appointing authorities are specified in the Annexure - I of this OM.

1.2 Review for promotion by the Selection Committee is done twice a year, that is before 1st January and 1st July of every year. Those who have completed or will complete five years of service in a grade during the period of three months before or
