

Minutes of the meeting of the all the Autonomous body under MOES pertaining to All Administrative matter held at IITM, PUNE on 24.4.2009.

A meeting under the chairmanship of Director (Estt.), MOES was convened with all Administrative Officers of all Autonomous Body on 24.4.2009 hosted by Director, IITM PUNE wherein the follow-up action on the points discussed at NIOT, Chennal on 19-20<sup>th</sup> January, 2009 along with new issues pertaining to Pension, Unified Recruitment Rules, merger of Pay Scales etc. were discussed. The points / discussion /decisions thereon are given below:

5i. No.	Items Discussed	Action/decisions
01	Review of action on the recommendations of the meeting held at Chennai	All the autonomous bodies have decided to implement the Medical Benefit Scheme as recommended in the last meeting.
02	Merger of Scales	<ol> <li>i) INCIOS has already implemented the merger of Scales in PB-2 with the grad pay of Rs.4800/- for their officers who were drawing pay in the pre revised scale of Rs. 6500- 200-10500.</li> </ol>
		ii) HTM Pune has already implemented the revised pay scale with the Grade Pay of Rs. 4600 in PB-2 where the essential qualification is B.Tech or PG in Science subjects. NIOT & NCAOR have yet to implement the same and have the advised to implement immediately.
		iii) iiTM /NCAOR/NIOT have been advised to take action as per 6th CPC in respect of Administrative posts.
03	Filling of vacancies	All the institutes are to figure out the correct vacancy position and have been advised to take immediate action for filling up of vacancies and submit the latest vacancy position within one month.
04	Promotion channels	All the Institutes have been advised to change the nomenclature of Scientific / Technical and Administrative Posts to bring the posts at par with those of Central Government Departments as per the essential qualifications, age etc. so that matching pay scales can be finalized and promotion channel be devised. NIOT and NCAOR has to circulate the draft proposal for the same within 3 weeks.
05	Pension Scheme	SBI, Mumbai Branch gave a Power point presentation (PPT) highlighting the salient features of their scheme. All the Autonomous Institutes have been advised to interact with the

Scheme providers (Fund managers) and to get the details regarding all aspect including maintenance of corpus fund, annuity kit etc. If IVI have to explore the possibilities of shifting over of its employee's pension fund from the existing fund operations.

06 Revised/preparation of RR based on 6<sup>th</sup> Pay Commission recommendations A draft RR was discussed by the members, and an exercise to have uniform qualification, age, experience etc. for all the autonomous bodies is being carried out. Draft RR have been circulated to all the members for finalization as per requirements of their institute.

07 Gratuity Scheme to Contract employees It was pointed out by the members that it is applicable only to regular employees & not applicable for the employees, who have worked less than five years. However, as the Institutions showed interest to have new fund manager for Gratuity on the lines of new pension scheme, the institutions are advised to collect the relevant information and to place before the next meeting.
