

Sub: Complaint by Shri G.Vadivelan -reg.

This has reference to the mail requesting inputs for the complaint received from Shri G.Vadivelan regarding illegal approach on activities of NIOT during the period of 2010 – 2015. As instructed by the Director, this matter was referred to Establishment & Personnel Section and concerned groups of NIOT and the pointwise inputs received are given below:

- 1) The allegations in SI.No.(1) and (2) basically deal with Shri Shailesh Nayak. The veracity of the contents in these allegations is beyond the knowledge of E&P Section of NIOT.
- 2) Promotion order was issued to Dr.M.A.Atmanand as Scientist-G based on orders of MoES vide letter No. F.No.MoES/18/06/2010-Estt. dt.14th September 2011. Order withdrawing the letter of MoES dt.14.9.2011, based on DoPT's communication (EO-SM-II) dt.22.2.2016 issued vide F.No.22/27/2014-EO (SM.II) (Vol. II) to review the promotion of Scientist-G has been received. Accordingly, the Ministry has reviewed the case and submitted the recommendations to Competent Authority for further orders.
- 3) With respect to Tamil Nadu State Government orders, NIOT has given an undertaking not to develop beyond the already developed 30 acres land out of the total NIOT campus of 50 acres. In view of the above, Pre Engineered Building structures (which can be shifted as and when required) have been constructed in already developed areas only with no reclamation. These buildings are essential for storage, integration and assembly of expensive state of the art equipment / Tsunami buoys etc. Also, environmental clearance has been obtained from Government of Tamil Nadu dated 1st March 2011 by presenting all these facts. Consent for establishment has also been obtained. All these clearances have been obtained prior to issue of work order to M/s.Priya Constructions on 4th March 2013.
- 4) So far, no specific complaint has been received from any corner on any recruitment in NIOT.
