CORRIGENDUM

In partial modification of E-Procurement Tender No. MoES/2/1/06/Comp/Pt-IV, the following clauses are added/modified :

Clause 2.1 (Addition) : In the following sites telepresence setup is not functioning properly :

a.	India Meteorological Department, Mausam Bhavan, Lodi Road, New Delhi – 110 003.	The Primary Codec is not getting connected.
b.	National Centre for Medium Range Weather Forecasting (NCMRWF), Sector-62, Noida	Secondary codec is not synchronizing with primary and third codecs; Creston Touch Panel Controller is not getting up; Audio Woofer is not working.
c.	Indian National Centre for Ocean Information Services (INCOIS), "Ocean Valley", Pragathi Nagar (BO), Niampet (SO), Hyderabad - 500090	Secondary codec is not getting connected; CRESTON touch panel is also not getting up.
d.	National Institute of Ocean Technology (NIOT), Velacherry-Tambaram Main Road, Narayanapuram, Pallikaranai, Chennai - 600 100, Tamil Nadu, INDIA	Third codec is not getting connected; CRESTON touch panel is also not getting up; One of the ceiling mike is not working.
e.	Ministry of Earth Sciences (MoES HQ), Prithvi Bhavan, Lodi Road, New Delhi – 110 003.	Audio woofer is not working.
f.	Indian Institute of Tropical Meteorology (IITM), Dr. Homi Bhabha Road, Pashan, Pune 411 008	Secondary codec is not getting connected; CRESTON touch panel is also not getting up

The scope of repairing work of above said faulty equipment has been included in the scope of work.

The bidders are required to submit separate quote as per Price Bid-II. The terms and conditions for this work is mentioned in the Price Bid-II itself.

The Proforma of Price-Bid-II with terms and conditions is attached.

Clause 2.2 (Additon) :

The total of Price Bid – I (Cost for AMC) and Price Bid-II (for repairing work) will be deciding factor for identifying L1 bidder.
